Those born in 2008-2009 interested in playing travel soccer do not have to tryout but they must pre-register for the 2017-2018 season. During this time, you will turn in the attached form below and your player will get their photo taken.

Tryouts are required for those wanting to play in the U11 and older age groups in the travel program.

Make sure you arrive 15-20 minutes early to get checked in.

- All players must attend at least one tryout session as their roster spot will be determined from the performance given at their tryouts.
- All participants must bring their own ball and water bottle. Shin guards and appropriate soccer shoes are **required equipment** for tryout.
- In accordance with Iowa Soccer Association rules and policies, U11-U18 players that make teams will receive an invite after tryouts via a phone call or email. Information regarding team acceptance will be distributed at tryouts.
